


Established in 1995, the Coalition of New York State Public Health Plans is an important voice for New York’s non-profit, publicly-focused health plans and their members. All Coalition plans are sponsored by or affiliated with public and not-for-profit hospitals, community health centers, and physicians.

Public Health Insurance Programs

The Coalition represents eight plans serving **more than 3 million individuals**—approximately two-thirds of all adults and children enrolled in New York’s Medicaid managed care and Child Health Plus programs. Over the past five years, Coalition plans have extended their services to higher need, more medically complex populations. Collectively, our plans have been responsible for the success of many of the Medicaid Redesign Team’s ambitious initiatives, including the transition of more than twenty benefits and populations to managed care, such as the pharmacy and long-term-stay nursing home benefits and the homeless and low birth weight infant populations. Given their longstanding mission, our plans are expected to carry a similar responsibility for the success of the State’s Basic Health Program this year and next.

Our plans have decades of experience **delivering high-quality services** to populations that have traditionally faced significant barriers to health care, and they consistently receive high marks in quality of care and member satisfaction. In 2013, all of our mainstream managed care plans received a quality incentive bonus from the State.



Marketplace Plans

The Coalition has supported State efforts to design, establish, and implement *New York State of Health*, the State’s Health Insurance Marketplace, to improve access to affordable coverage in both the individual and small group markets. Four Coalition plans offer qualified health plans (QHPs) through the Individual Marketplace and, during the Marketplace’s first year, collectively accounted for **more than a third (36%) of QHP enrollment**.
